

#### WTP 2035 OUTREACH JOURNAL

The Washington State Transportation Commission, with assistance from the Washington State Department of Transportation, and the state's Metropolitan Planning Organizations/Regional Transportation Planning Organizations, conducted a variety of outreach events during development of WTP 2035. The principal objective was to engage a wide variety of participants and seek their input both in developing the Draft WTP 2035, and following release of the Draft, their reaction to it. Beginning with a broad-based statewide Advisory Group that met four times during development of WTP 2035, the outreach process provided stakeholders and the general public across the state with opportunities to help identify trends, aspirations, constraints, and external influences that should shape transportation policy to meet the needs of the people of this state for safe and efficient transportation services for people and goods.

The various outreach events sought to raise the profile of the WTP 2035 update process and elicit information from a geographically and socioeconomically diverse cross-section of the state's transportation system users. Through presentations, roundtable discussion, open forums, and electronic Webinars, participants were polled on several key issues, including how regional transportation needs can be addressed through statewide transportation policy, and how the special transportation needs of groups such as the elderly and those with disabilities can be better met through greater statewide transportation policy coordination. Participants were encouraged to discuss their current and likely future transportation challenges, as well as potential solutions, at a systems level, rather than to describe specific infrastructure projects or programs. Finally, outreach participants were given opportunities to express their attitudes about the condition and performance of the state's existing transportation system, and the most appropriate ways to fund transportation priorities regionally and across the state.

## **Public Outreach Conducted During Preparation of Draft WTP 2035**

Staff from both the Transportation Commission and WSDOT gave a number of presentations around the state in the first half of 2014 to raise awareness about the WTP 2035 update and to solicit information and opinions from a wide range of agency and stakeholder organizations. This included four structured roundtable discussions held with invited stakeholders, conducted in April 2014.

#### **Media Outreach**

Release of the Draft WTP 2035 in July 2014 was followed with a media outreach campaign to place news articles about the Plan in TV, radio and print news markets across the state. More than 50 such placements were secured in Washington media outlets across the state. Stories appeared in every targeted region, including publications such as the Everett Herald, The Columbian, Spokesman-Review, Bremerton Patriot, Kitsap Sun, Daily Journal of Commerce and Washington Bikes, and several others. State Transportation Commissioners participated in several conversations with news reporters to discuss the plan. Following release of the final WTP 2035 in January 2015, a second wave of media placements and interviews were conducted.
